# 2021 GOVERNING COUNCIL ELECTION INFORMATION ON E-VOTING



Only financial fellows, associates and senior members will be allowed to vote.

Voters will receive information on the candidates and their profiles.

Voting will commence from Thursday 1<sup>st</sup> July, 2021 and end on Wednesday 14<sup>th</sup> July, 2021 (11:30a.m.).

Each eligible voters will receive a single user code to vote.

A voter is expected to vote for a maximum of four (4) candidates.

Any voter that marks more than four (4) candidates will receive an alert to vote for maximum of four (4) candidates.

Reminders will be sent to financial members to exercise their voting rights.

Evidence of voting will be shown immediately after successful voting.

The code can only be used once and is not transferable.

The result of the election and the relevant statistics will be forwarded to the Chairman of the Electoral Committee.

The Chairman of the Electoral Committee is to announce the result at the Annual General Meeting.
