Whilst speaking on the theme: 'Repositioning the Nigerian Insurance Industry' he called for cooperation amongst the insurance industry regulator-National Insurance Commission (NAICOM) and practitioners so as to engender growth and economic development.

Besides, the eye sees not itself. You will, therefore, permit me to be the mirror to show the reflection of the industry as I see it," he submitted.

CIIN promotes family values at Ramadan Tafsir

The Chartered Insurance Institute of Nigeria (CIIN) has once again restated its commitment to raising professionals, who should display professionalism at home and in the workplace.

To ensure insurance professionals demonstrate professionalism across board, the Institute in its 2022 Ramadan Tafsir Lecture tagged 'Nurturing Families: Panacea to Societal Ills and Youths Restiveness, underscored the role of parents in building good family units of the society.

The President of CIIN, Sir (Dr.) Muftau Oyegunle, giving his welcome address at the event which held at the Central Mosque, Alausa, Ikeja, said the Tafsir was derived from the Arabic word FASARA which literally means to lift the curtain, to make clear, to show the objective, stressing that by analogy Tafsir is the body of knowledge which aims to make clear the true meaning of Quran, its injunctions and the occasion of its revelations.

"I will like to remind us that we are in a season where we reflect upon the wisdom and guidance that comes with the Islam faith, and the responsibility that human beings have to one another, and to God. It is also a time of intense devotion to ALLAH.

"With these reasons, I urge us all here today to continue to use the Holy month of Ramadhan to stay close to Allah by seeking for forgiveness of our sins, praying for our Country, family and humanity in general," he said.

He submitted that the topic was very apt and very timely considering a lot of societal issues the world is encountering today. To address this menace, he said it should start from the family as it is said "Charity begins at home", adding that all individuals are primarily influenced and shaped into characters from the family they were born into before taking such features into the society. "So, I will say again that the family plays a very significant role in having a peaceful society", he concluded.

Entertainers to have robust insurance cover

Insurance practitioners have risen to the quest of entertainers in the country as efforts are being put in place to evolve products to suit their needs.

Insurance brokers are taking the lead in this regard as they have promised to partner their underwriting counterparts to develop arrays of policies to meet the needs of entertainers.

The President, Nigerian Council of Registered Insurance Brokers (NCRIB), Barr. Rotimi Edu, said this when the broking fraternity played host to the former President, Actors Guild of Nigeria (AGN) Mr. Segun Arinze, at the April edition of the NCRIB Members' Evening sponsored by the Universal Insurance recently in Lagos.

Barr. Edu, also requested that the Nollywood star should use his position as a scriptwriter to write an insurance story and have it acted to help drive insurance penetration and acceptance in Nigeria.

For his part, Mr. Arinze, called on Insurers to come to the aid of Nollywood members, stressing that many of them do not believe that insurance could cover them. He charged insurers to create robust insurance packages that will take care of Nollywood members' operations.

According to him, "It is so worrisome for us in the industry because some of us do not believe that insurance can cover us."

Mr. Arinze who described the situation as unfortunate called on insurers to do something about Nollywood in order to save them from unfortunate occurrences.

While inviting insurers to avail themselves of the existing opportunities in the Nollywood industry which he described as 'large' and 'humongous' Mr. Arinze called on the underwriters to send their proposal to the Nollywood industry for study and consideration.

Lagosians pay N55.52bn for life cover

agos State dwellers are embracing insurance as they spent N55.52 billion in 2020 to insure their lives.

Data obtained from the Nigerian Insurers Association (NIA) revealed that Lagosians spent N51.95 billion on Group Life insurance and N3.57 billion on Individual Life Insurance.

Lagos State which has remained the leading light on insurance patronage, was followed by the Federal Capital Territory (FCT), Abuja as people living there spent N17.38 billion to insure their lives, while people in Rivers State spent N3.42 billion.

The data showed that people living in Yobe; Zamfara; Taraba; Nasarawa; Katsina and Jigawa States did not subscribe to individual Life Insurance, while those in Kebbi and Bauchi failed to have Group Life.
