Their experiences as insurance professionals/ practitioners may be from the insurance sector; Underwriting, Broking, Loss Adjusting and other sectors of the insurance industry.

CRITERIA FOR BECOMING A MENTOR:

- 1. Must be a financial professional member (Fellow or Associate) of the Institute with details captured in the Institute database.
- 2. Must have a minimum of 5 years experience as a professional in the insurance industry.
- 3. Must not have been convicted by any court of competent jurisdiction for any criminal offence, harassment, fraud, etc.
- 4. Must not have been removed or suspended as a professional for misconduct before the expiration of employment.
- 5. Must be willing to receive and mentor mentees from any gender, ethnic group, sector, religion and age
- 6. Must have been screened and approved by the Institute.

Note: CIIN can invite notable experienced insurance experts who have met the eligibility requirements to be mentors in the program. Details of such invited persons will also be submitted to the selection committee for approval.

TERMS AND CONDITIONS FOR THE MENTOR

Being a Mentor of the Institute is a voluntary effort towards giving back to the society. Thus, there is no financial remuneration offered to Mentors.

- 1. Mentors must have the time to schedule sessions with their mentees and give maximum attention to the program.
- 2. Mentors must make themselves accountable to the supervisory and administrative structures put in place for this mentoring programme.
- 3. Mentors must abide by the Institute's rules and regulations under this programme.
