2.0 OPENING

The Director General, Mrs. Abimbola Tiamiyu read out the notice of the meeting and confirmed that it was issued in accordance with the provisions of the Institute's Enabling Law.

4.0 MINUTES OF THE ANNUAL GENERAL MEETING HELD ON WEDNESDAY JULY 14, 2021

4.1 Adoption of the Minutes of the Last Annual General Meeting

The minutes of the Institute's 2021 Annual General Meeting held on Wednesday July 14, 2021 at the National Secretariat, Chartered Insurance Institute of Nigeria, 27 Lagos Street, Ebute-Metta, Lagos State were considered and subsequently adopted, as circulated without any

amendment, as the correct record of proceedings based on the motion moved by Mr. Jide Orimolade (Stanbic IBTC Insurance Limited) and seconded by Mr. Olasunkanmi Adekeye (Lagos State).

4.2 Matters Arising from the Previous Annual General Meeting

The Director-General addressed the following matters arising from the 2021 Annual General Meeting.

- **4.2.1 The Appointment of New External Auditors:** Messrs. PKF Professional Services were appointed as the new external auditors for the Institute following the termination of the appointment of Messrs. Adewuyi Adetunji & Consulting. The Finance and General Purposes Committee supervised the appointment on behalf of the Council.
- **4.2.2 Update on Fraud Committed by Mr. Emmanuel Emenuwe:** It was stated that Investigation was still ongoing regarding the case of the fraud committed by the former Finance Director of the Institute. Mr. Emmanuel is still at large but has been declared wanted by the all-relevant Government agencies.

5.0 President's and Governing Council Reports

The President's and Governing Council reports was circulated to all members prior to the meeting. The reports were adopted following the motion for adoption moved by Lady Isioma Chukwuma (Lagos State) and seconded by Mr. Adeniran Aderinoye (AIICO Insurance Plc). Consequently, the President drew the attention of members to page four (4) of the annual report which captured the Institute's core values and he encouraged members to be duly guided by these values in all their endeavours and at all times. 6.0 FINANCIAL REPORTS

6.1 Treasurer's Report

The Treasurer of the Governing Council, Mrs. Yetunde Ilori, (Nigerian Insurers Association) presented the financial statement of the Institute as at the year ended December 31, 2021. She assured the members present at the meeting of the resolve to continue to take the necessary steps to ensure that all Institute's resources are properly and judiciously administered and proficiently managed.

6.2 External Auditor's Report

The external auditors, Messrs. PKF Professional Services, was represented by Mr. Komolafe Ifatunde. He presented the consolidated audited accounts and reports on the Institute and confirmed that the report was presented independently of the Institute's influence, with all materials presented being in accordance with the International Standards of Auditing (ISAS) and the International Ethics Standard Board for Accounting Code of Ethics.

The President commented that the report presented by the representative of Messrs. PKF Professional Services is the true financial position of the Institute.

The report of the financial year ended December 31, 2021 and the auditor's report were adopted based on the motion moved by Mr. Adeniran Aderinoye (AIICO Insurance Plc) and it was seconded by Mr. Olusegun Akintunde (Heirs Life Assurance Plc.)

7.0 (RE)APPOINTMENT OF AUDITORS

The Treasurer, Mrs. Yetunde Ilori (Nigerian Insurers Association), in view of the satisfactory performance of the external auditors recommended the re-appointment of Messrs. PKF Professional Services as auditors for the incoming year. The motion was seconded by Mr. Ademola Abidogun (Guinea Insurance Plc), and thereafter adopted by the Congress.

8.0 **ELECTION INTO GOVERNING COUNCIL**

8.1 Vacant Seats and Candidates

The Chairman of the Electoral Committee, Mr. Bola Temowo, announced the names of the five (5) candidates that contested for the four (4) vacant seats in the Council of the Institute as shown below.

Election Results 8.2

The Chairman Electoral Committee, Mr. Bola Temowo, announced that a total number of 1375 were eligible to vote and out of which 877 casted their votes. He confirmed that they were no reported cases of fraud committed during the election. The results of the election were announced as shown below:

The President/ Chairman of Council, Sir (Dr.) Muftau O. Oyegunle congratulated the reelected members of the Governing Council as well as the newly elected members. He thereafter announced that Council members needed to recede immediately and convey a brief emergency Council meeting.

The President, after the emergency Council meeting, announced the election of Mr. Edwin Igbiti as the 51st President of the Institute and Mrs. Yetunde Ilori as the Deputy President. He enjoined members to support him during his tenure. This motion of Council was seconded by Mr. Muyiwa Aderibigbe (Zenith General Insurance Company Limited).

The President further informed the members that there was a vacuum in the membership of the Council as a result of the election of Mrs. Yetunde Ilori as the Deputy President of the Institute. It was therefore recommended by Council that the candidate with the fifth position, Mr. Olamide Olajolo be elected to fill in the vacant seat in the Governing Council. This recommendation was thereafter adopted as a motion, which was seconded by Mrs. Tosin Bayo-Yusuf (Heirs Life Assurance Limited) and consequently ratified by the members present.

8.3 **CLOSING REMARKS**

Mr. Edwin Igbiti, the President-Elect, appreciated the Immediate Past President for his contributions to the Institute, from whom he is taking over the mantle of leadership, all members of the Institute, as he said he counts on their support for a successful tenure – as they did with earlier Presidents; and announced that the investiture ceremony for his presidency will hold on Friday, July 15, 2022.

9.0 **ADJOURNMENT**

The motion for adjournment was moved by Dr. F. K. Lawal (Sterling Assurance Nigeria Limited) and seconded by Mr. Sunny Adeda (Alpha Choice Insurance Brokers Limited).

The closing prayer was taken at 12:35p.m by Mr. Olusegun Omosehin (Old Mutual Nigeria Life Assurance Company Limited) after which the meeting came to an end.
