The bootcamp focused on effective mentorship, providing participants with valuable insights and practical tools to enhance their professional development.

The Sixth Edition of the CIIN Mentorship Programme, tagged Bootcamp 6.0, themed: 'Mentorship, Mindset and Momentum: Unlocking career growth in a fast-changing world', was held at the College of Insurance and Financial Management (CIFM), Aseese, Ogun State.

The two-day event, which started on Friday, August 15, and Saturday, August 16, 2025, hosted 74 participants from across various arms of the industry: Underwriting, Broker and Loss Adjusters.

CIIN President/Chairman of Council, Mrs. Yetunde Ilori, FIIN, declared the camp opened at 3:15 pm after the Institute Registrar, Mrs. Abimbola Tiamiyu, FIIN, PhD, presented the participants to the President.

The Entire Council of CIIN appreciated the working visit of the Commissioner to the Institute.

SDGs AND THE INSURANCE BUSINESS

Global Momentum and the Case for Sustainable Insurance in Nigeria (Part 2)

In the first part of this series, we looked at the global momentum behind sustainable insurance. We saw how insurers worldwide are channeling trillions of dollars into renewable energy, green bonds, and ESG-driven products. Beyond aligning with climate goals, these choices are proving profitable, boosting brand reputation, and opening doors to new markets. For Nigeria, where climate risks are growing and insurance penetration is still under 2%, this global shift offers both a challenge and a chance. The question is: how do we translate global trends into local impact?

The reality is that Nigeria's insurance industry faces deep-rooted barriers. Many people still see insurance as a "luxury" rather than a necessity, which makes adoption slow. Concepts like climate risk or green finance can feel distant from everyday struggles, so it is not always easy for insurers to explain why sustainability matters. On the regulatory side, the National Insurance Commission (NAICOM) has made progress on solvency and compliance, but clear sustainability guidelines and ESG reporting standards are still lacking. Without them, it is difficult for companies to move in the same direction.

Another obstacle is data. Sustainable insurance relies on accurate climate and social risk information, but Nigeria's infrastructure for collecting and analyzing such data remains weak. This makes it hard to design affordable products like flood or crop insurance. Add to that the challenge of capital: many local insurers are under-capitalized, leaving little room to experiment with bold ideas or tap into international pools of green finance.



Yet, despite these hurdles, the case for change is undeniable. Climate risks are hitting harder every year. The 2022 floods displaced over 1.4 million people, showing just how vulnerable communities and businesses are without proper risk cover. At the same time, Nigeria has one of the youngest populations in the world, and this generation is tech-savvy and open to innovation. If insurers design products that are affordable, digital, and linked to real needs—whether in farming, small businesses, or renewable energy—there is a huge untapped market waiting to be reached.



Global investors are another reason to act quickly. As capital flows increasingly favor ESG-aligned industries, insurers that ignore sustainability risk being left behind. By contrast, those that embrace it could unlock funding, partnerships, and growth opportunities.

So, what can be done? Regulators can set a clear roadmap for green insurance, while insurers partner with reinsurers, fintechs, and development agencies to access expertise and capital. Technology—especially mobile platforms and digital data tools—can bridge gaps in access and trust. And finally, professionals within the industry need training to design and deliver products that blend business sense with social impact.

If Nigeria takes these steps, sustainable insurance could become more than just an imported concept—it could be the key to resilience, relevance, and growth in the years ahead.
