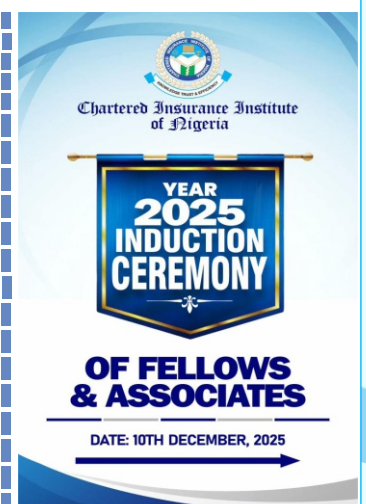
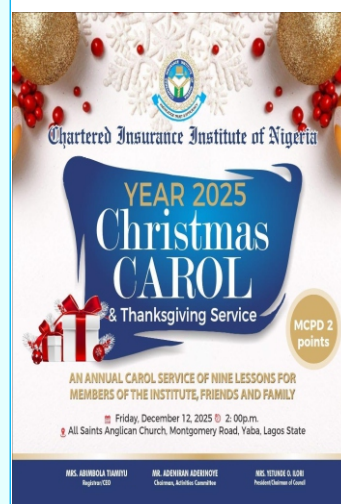

The President/Chairman of the Institute's Council, Mrs. Yetunde Ilori, stated this during the Year 2025 Education Conference in Enugu, stating that

the days of traditional insurance is over, hence insurance practitioners need to embrace insureTech to remain in business.

Mrs. Ilori, charged participants at the Year 2025 Education Conference to adopt AI in transacting insurance business and remain professional in their transactions.

She added that insurance is a business of trust, therefore, ethics is very important, adding that practitioners must be diligent, professional and ethical in their daily practice.

IICC Trains Enugu State Workers On Compulsory Insurances

The insurance industry in its bid to promote insurance awareness and penetration through the nooks and crannies of Nigeria, preached the gospel of insurance in Enugu.

President Bola Ahmed Tinubu, GCFR signed the Nigerian Insurance Industry Reformed Act (NIIRA) 2025 into law in the month of July. The Act is expected to reform the insurance industry, ensure Nigerians embrace the benefits of insurance which is a catalyst to growing the Nigerian economy.

It was in light of this, the Insurance Industry Consultative Council (IICC) under the leadership of its Chairman. Mrs. Yetunde Ilori, FIIN led all Arms of the industry, NAICOM, NIA, NCRIB, ILAN, ARIAN and CIIN to the heart of Enugu where the Government seats to preach the gospel of insurance to several delegates from various ministries of the State Government.

Mrs. Ilori, said bringing the Year 2025 edition of the IICC Compulsory Insurance to Enugu was intentional, she added that the industry thought it was necessary for Enugu to feel the industry, noting that the State Government under the leadership of the Governor, Barr. (Dr.) Peter Mbah has been so involved in promoting compulsory insurances in the State.

She also appreciated the Government for supporting the training by approving the attendance of its workers.

The President of ILAN, Ikechukwu Udobi, addressed the delegates as being privileged to have been selected out of many to attend the training. Speaking on behalf of the Government, the Secretary to the State Government, Professor Chidebere Onya, appreciated the industry for deeming it fit to train the citizens of the Coal City State on benefits of insurance.

He stated that insurance is indeed a catalyst to growing the State's economy and the Government is definitely going to take advantage of this.

The delegates applauded the IICC for the thoughtful training with the calibre of experienced experts who delivered several informative and innovative papers on compulsory insurances.

Expert Urges Insurance Journalists To Confront Burnout Amid Mounting Pressures

Journalists covering Nigeria's insurance industry have been urged to take deliberate steps to protect their mental and physical well-being as the demands of the newsroom continue to intensify.

The call was made by Dr. Tunde Jesusina, Director of Medical Science at the Federal Polytechnic, Ilaro, during a capacity-building programme for insurance correspondents organised by the Insurance Industry Consultative Council (IICC) at the College of Insurance and Financial Management (CIFM), Ogun State.

Speaking on the theme "Beyond the Byline: Managing Burnout in Nigerian Journalism," Jesusina warned that burnout goes far beyond ordinary stress, describing it as a progressive condition that evolves through emotional, physical, and mental exhaustion; increasing detachment and cynicism; and a gradual decline in professional effectiveness.

He noted that systemic challenges in Nigeria create a "perfect storm" for burnout among journalists. These include harsh economic realities such as low wages and rising living costs, an overwhelming 24/7 news cycle driven by information overload, persistent security risks, and poor working conditions characterised by inadequate resources and institutional support.

Jesusina outlined key warning signs of burnout, citing chronic fatigue, recurring illnesses, disrupted sleep, anxiety, irritability, and feelings of helplessness as major red flags.

Behavioural indicators such as detachment, procrastination, difficulty concentrating, substance reliance, and social withdrawal, he said, also signal that a journalist may be nearing exhaustion.

To rebuild resilience, he advised journalists to prioritise rest, maintain regular physical activity, reconnect with personal interests outside work, and adopt mindfulness or spiritual grounding practices.

Seeking professional counseling, he emphasised, should be viewed as a sign of strength rather than stigma.

Global Momentum and the Case for Sustainable Insurance in Nigeria (Part 5)

Looking ahead, the future of sustainable insurance in Nigeria is full of potential. By 2030, it is possible to imagine a landscape where farmers in the North and Middle Belt receive timely payouts for droughts or floods via mobile platforms, allowing them to recover and reinvest quickly. Renewable energy projects in underserved communities could benefit from tailored coverage that reduces risk for investors, accelerates adoption, and helps address the country's energy deficit. Microinsurance schemes for informal workers, health insurance for mothers and children, and ESG-linked coverage for SMEs could become the norm rather than the exception. In each case, insurance becomes more than risk protection—it becomes a tool for resilience, inclusion, and sustainable growth.

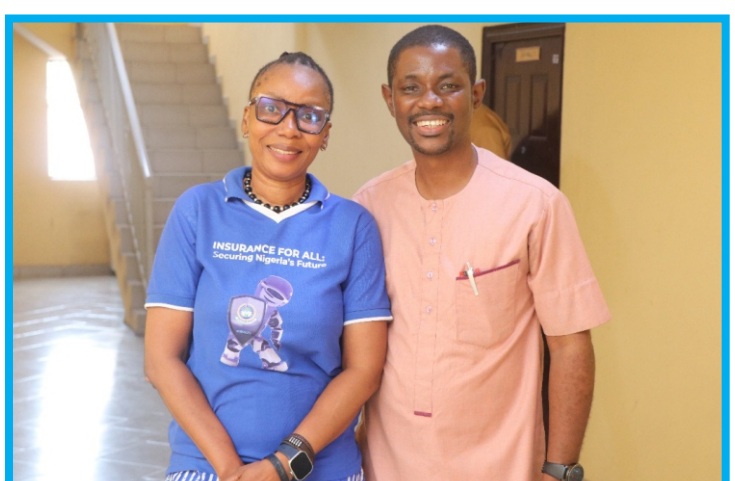
