ELECTION TO THE GOVERNING COUNCIL OF THE INSTITUTE YEAR 2026 COUNCIL ELECTION

CONDITIONS FOR ELECTION

- The applicant must not be below thirty (30) years.
- The applicant must be an Associate or a Fellow of the Institute.
- The applicant must possess a minimum of ten years (10) post qualification experience.
- The applicant must have been in professional practice for a minimum of ten (10) years.
- The applicant must be nominated and referred by two (2) professional members of the Institute.
- The nominated and nominating/referencing members must be an “Active Member (i.e. a financial member with up-to-date administrative record)” in the last three (3) years including the year of election.
- The applicant must have the minimum cumulative MCPD score (120 points) in the last three years including the year of election.
- The applicant must submit a letter of attestation to professional integrity and to being of good character by his/her employer.
- For those not currently in employment as at the time of application, submission of a letter of attestation to professional integrity and to being of good character by a Fellow of the Institute, who is an “Active Member (i.e. a financial member with up-to-date administrative record)” as at date of writing the letter.
- The applicant must appear before the Council, through appearance before the Membership and Professional Standards Committee, for an interactive session.
- Applicants without the opportunity of having served in any Committee of Council must show evidence of participation in Institute's activities.
